Maharashtra Maritime Board (MMB), a premier port development and regulatory agency of Maharashtra Government, intends to promote port sector and develop port projects on PPP basis. The major scope of the assignment is:

- Knowledge Partner and Investment Promotion Advisory Services
 - Preparation of Investment Promotion Strategy & Content Management
 - Implementation Assistance for investment promotion activities
- Project Development Consultancy Services
 - Identification and conceptualization of project/s
 - Feasibility study of the identified project/s
 - Bid process management and marketing of the project/s
 - Assistance in identifying the strategic partner for the project/s

Proposals are invited from globally reputed Consultancy Firms for providing professional services towards the above scope. The Consultancy Firm shall verify whether they are qualified as per the following Qualification Criteria, before submission of proposal:

- The turnover/ income from operations only from providing advisory/ consultancy services shall not be less than Rs. 100 crore or equivalent in foreign currency in at least two out of previous three financial years
- The Consultant must have carried out minimum ONE project as a Lead Consultant / Project Advisor's in investment promotion in ports/ maritime sector in India in the past five years
- The Consultant must have undertaken feasibility study for minimum ONE infrastructure project with project cost of more than Rs. 500 crore in the past five years
- The Consultant must have successfully selected a private developer on PPP basis for minimum ONE infrastructure with project cost of more than Rs. 500 crore in the past five years
